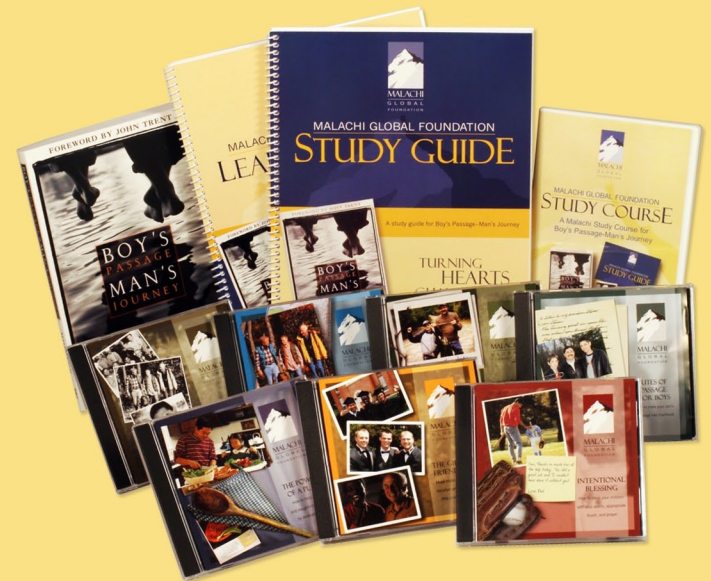

We provide professional digital coverage. Images are photographed in Color & can be converted to Black & White, Sepia & Custom Fine Art Design. Event & Corporate coverage is provided in a journalistic style & Product coverage is provided on location or at our studio.

■ **PROOFS** will be ready to view approximately 3 weeks after your session. Proofs will be presented either on a DVD slide show, as purchased 4x6 prints, printed in a proof magazine, digitally online or digitally at our studio. Proofs are not touched up or Digitally Enhanced. Digital Enhancement, Color Conversion & Custom Fine Art Design are offered at no additional cost for all other Prints, Albums & Printed Products.

■ **HIGH RESOLUTION DIGITAL NEGATIVES WITH COPYRIGHTS** are included with Event, Corporate & Product Sessions if you have contracted us for at least 4 hours of coverage. Digital Negatives are not touched up or digitally enhanced. Enhanced images will be provided for an additional \$15 per image.

■ **SECURE YOUR DATE** To reserve your session & secure your date, a non-refundable \$25 retainer must be received along with a signed contract. The retainer fee will be applied toward your remaining balance due.

■ **TRAVEL RATES** For locations outside of a 30-mile radius of Mount Pleasant, MI, please inquire for a travel quote.

■ **PAYMENT INFORMATION** The session fee & travel fee must be paid in full no later than 2 weeks before the date of your session. Prints must be paid for in full when you place your order. All fees are non-refundable. Our fees & policies are subject to change without notice. However, session fees are guaranteed at the rate current to the time the retainer fee is paid. All other prices quoted for professional services, photographs & albums are valid for a period of three months following the date of your session. Orders placed after this period are billed at the studio's current pricing, which may be greater. 6% MI Sales Tax will be charged for services & products we offer.
